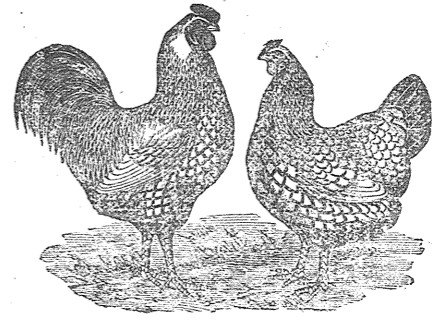

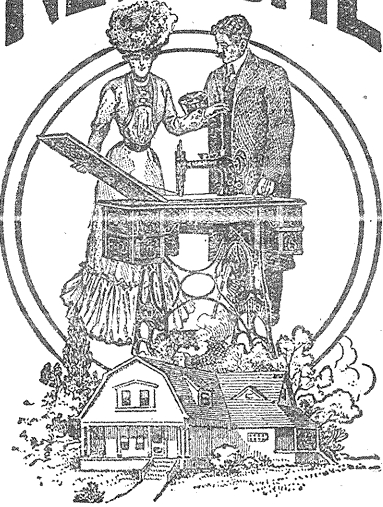

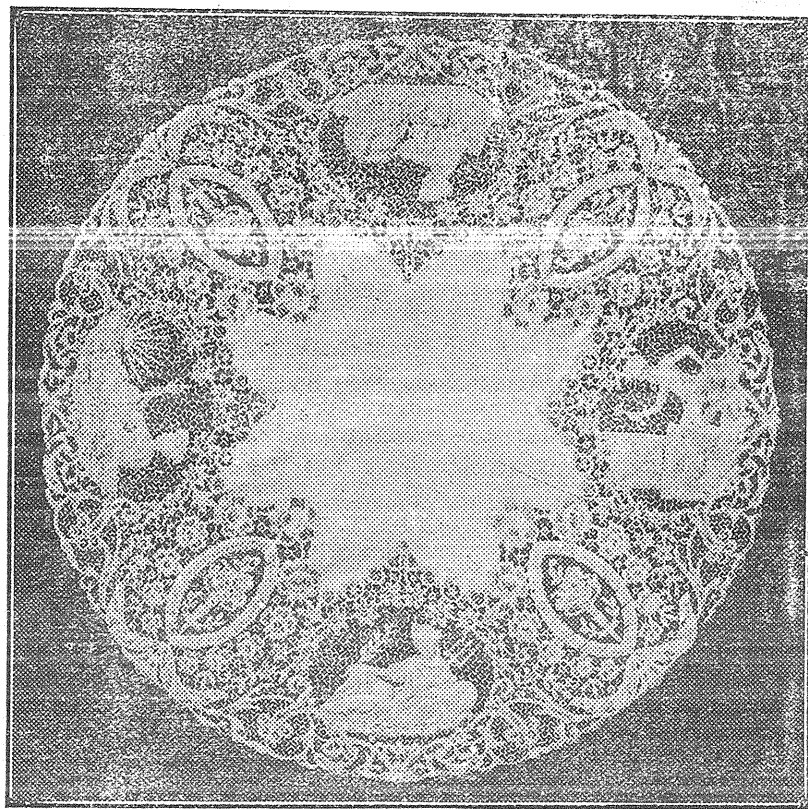

GRACEFUL CLASSIC FIGURES IN EMBROIDERED MEDALLIONS



HANDSOME TABLE CENTER

MEDALLION effects are popular in fancy work. A handsome specimen of this cut work is illustrated here. The figures used are those of the Greek gods and goddesses, those represented in this case being Amphitrite, goddess of the ocean, with her trident; Vulcan, with his hammer; Minerva, with her orb, and Aurora, goddess of the dawn, with her torch. Between the various motifs a pretty torch design is used. A lace braid is used in elaborating the embroidery. Punched work darned on scrim also affords a good medium for carrying out these charming medallion figure effects, which remind one of the graceful figures outlined on old wedgwood jugs and vases.

LENTEN FARE.

Dainty Dishes That are Suitable for the Season.

Anchovy Omelet.—Take three eggs, break them into a bowl, beat them with a tablespoonful of milk, pepper and salt till frothy. Fry some chopped onion and parsley in an ounce of butter without coloring them. When partially cooked add the beaten eggs and stir quickly with a wooden spoon. When the omelet begins to set work it into half moon shape and hold it slantingly before the fire to brown the top or else hold a salamander over it. Slip on to a hot dish and place in the center some filleted and heated anchovies or anchovy paste. Fold the omelet over and serve very hot.

Baked Loaf of Salmon.—Take a can of firm, nice salmon, drain the liquor from it, then flake the fish and add the liquor with a half cupful of bread-crumbs, the yolks of four eggs, two ounces of melted butter, with chopped parsley, salt and pepper to taste. Then add the whites of four eggs beaten stiff and a little lemon juice. Bake for half an hour. This is delicious served cold.

Serve with white sauce or any fish sauce preferred.

Rice Balls.—Take two cupfuls of cold boiled rice, one lump of butter, one-half cupful of flour; mix thoroughly and make into small balls. Roll in egg and then in flour or cracker dust, float in hot fat and fry till a light brown. Serve with powdered sugar and cinnamon.

Artificial Gems.

A few decades ago women did not care to wear jewelry that was not real. Now a change has come over things, and there are few who have not in their jewel case a few paste ornaments. Very beautiful are these artificial gems. Indeed, it would often require an expert to differentiate between them and their prototypes. A string of pearls is now ubiquitous, and pretty slides can be had mounted on black velvet or moire. These fulfill the missions of a necklet as well as a wristband. Again, there is a wealth of choice in brilliant shoe buckles, though sometimes a single stone takes their place.

RAG DOLL DANCE.

A Charming Diversion for the Children's Party.

A rag doll dance makes an amusing diversion for a children's party, is enjoyed by dancers and onlookers and requires very little in the way of frocks, scenery or properties.

Let two little girls be draped as rag dolls as follows: Put the costumes on with the back of the garments in front. Pin ruffled bags, bibs and aprons on the girls' backs, and paint faces on cloth to fit smoothly over the backs of their heads, and surround these by a ruffie, like a cap.

Let the two girl dolls lie flat on a table placed behind some portieres. Draw the portieres aside. The dolls should now slowly ascend as a clock is made to strike 12. They (the dolls) begin to come slowly to life by odd jerks and starts, and while some one plays softly on the piano they struggle to the floor, recover their balance and execute a loosely jointed, floppy dance.

As the clock is made to strike 1 the dolls bow with the effect of bending far backward and, slipping, sliding and bumping, tumble back on to the table.

If well done the rag doll dance is very great fun.

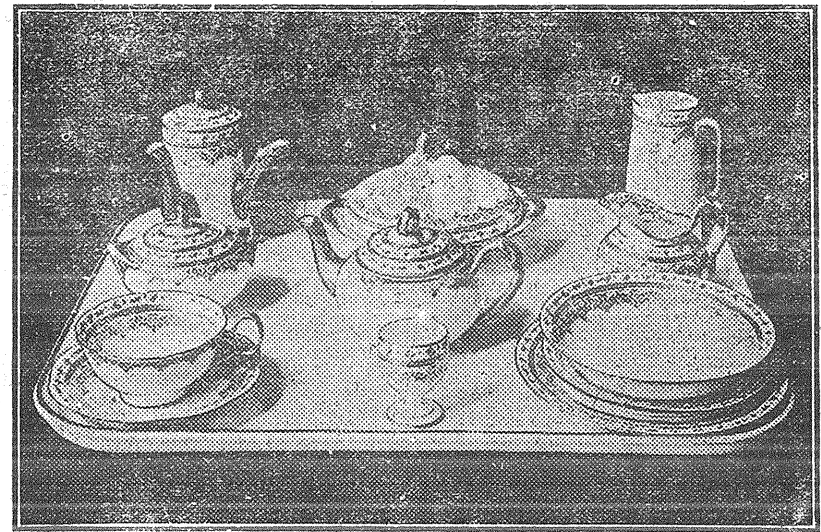
Eradicating Grease.

Grease in the sink is often a cause of disease. It cannot but accumulate from dishes and utensils, and when small bits of vegetable matter adhere to it a shelter is given to mischievous bacteria. Besides, grease will clog the drain and become a menace and an inconvenience. The surest and simplest cleansing agent is a strong solution of washing soda and boiling water. The sink should first be scrubbed with soap and the hot solution then dashed down the drain. This cleaning should be done at least once a week.

About Dollies.

If dollies and table centers are made at home instead of hemming the edge it is much better to buttonhole stitch it. This can be easily done if two circles are drawn with common lead pencil on the linen, about one-sixteenth of an inch apart, then buttonhole stitched between lines with pearl edge to the outside. When finished, cut away linen round edge.
