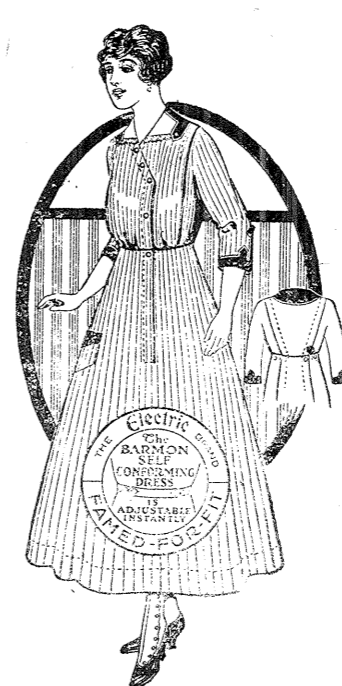
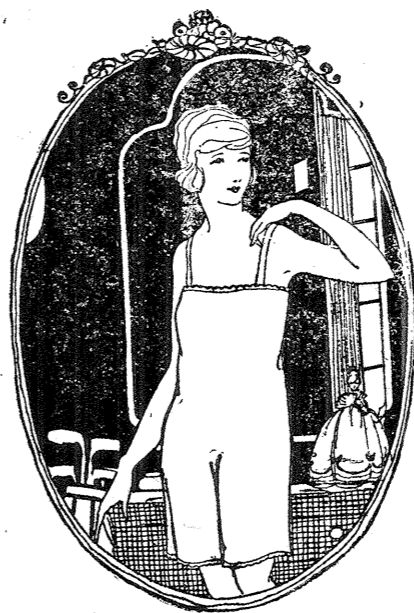

NESTLE'S CO. HOST TO 130 GUESTS

Spirit is commendable and I congratulate Manager Rittenhouse, the employees of the condensary and the business men of Cass City on the co-operative spirit shown at this event."

C. W. McKenzie of Kalamazoo, formerly cashier of the Cass City Bank, said the best time of his life he spent in Cass City, but never while a resident there did he witness such a business gathering as this one. Mr. McKenzie is a firm believer in organization and the spirit of everyone getting together, he says, can accomplish more than anything else you can do.

"Cass City can be justly proud of her high school athletes. They represent not only your high school but you in the athletic field and in the way of being gentlemen," said Mr. McKenzie. "Representatives of every worth-while college in the state will seek to have your athletes enter their colleges if they have not already done so.

"The Nestle's Food Co. is built along lines that bring results. If people who are employed and people who are employing would take into consideration the human element, a great many of our industrial problems

would be solved. The success of the co-operation of the management and employees of the Nestle's plant is appreciated by the people of Cass City."

A new condensed milk plant is ordinarily a losing proposition to the company operating it for the first 15 to 24 months, but the Cass City condensary proved a notable exception to this general rule. Here it was a losing proposition for only six weeks, said the superintendent, and it has been a winner and a money-maker ever since because of the co-operation of farmers, haulers, employees and citizens. The Cass City plant has broken all records of the Nestle's Co.'s string of condensaries.

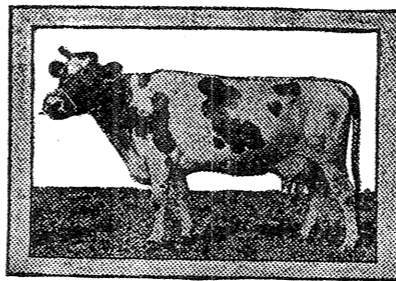

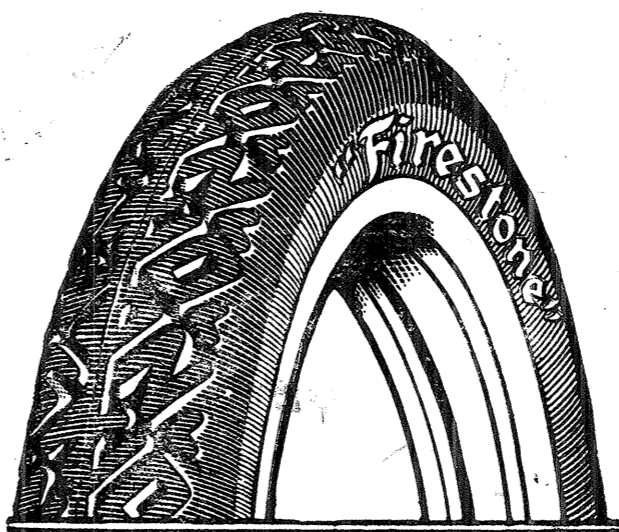

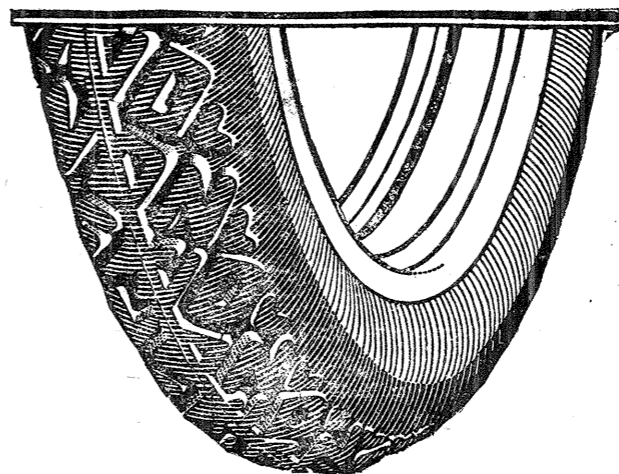
